

**Official Rules**

**"MTV Movie and TV Awards Weekend Promotion"**

**Sponsored by MTV**

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. A TWITTER ACCOUNT AND INTERNET ACCESS ARE REQUIRED TO ENTER. VOID OUTSIDE OF THE FIFTY (50) UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.
2. **Entry Period:** The **"MTV Movie and TV Awards Weekend Promotion"** (the **"Sweepstakes"**) commences at 12:00:01 PM Eastern Daylight Time (**"EDT"**) on June 4, 2022 and ends at 12:01:01 AM (EDT) on June 6, 2022) (the **"Entry Period"**). All entries must be received by 12:00:01 AM (EDT) on June 6, 2022.
3. **Eligibility:** This Sweepstakes is only open to individuals who are legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years of age at the time of entry. If eighteen (18) is not the age of majority in jurisdiction in which entrant resides, entrant must obtain the consent of his/her/their parent or legal guardian to participate in this Sweepstakes and if selected as a winner, entrant's parent or legal guardian must execute the prize release documents set forth in Section 6 on winner's behalf. Individuals who are employees, officers, directors, agents or representatives of MTV (**"Sponsor"**), Viacom International Inc., Paramount Global, Twitter, Inc. (**"Twitter"**) and their respective parent companies, affiliates, subsidiaries, advertising, production and promotion agencies or suppliers of materials or services related to the Sweepstakes (collectively, the **"Sweepstakes Parties"**), as well as their immediate family members (defined as parents, children, siblings and spouses, regardless of where they live) and those with whom such individuals are domiciled (whether related or not) are not eligible to enter this Sweepstakes. 4. **To Enter:** Entry is via Twitter only. During the Entry Period, log into your own Twitter account and accurately Tweet the hashtag (the “**Sweepstakes Hashtag**”) that will be revealed by Sponsor on-air during the twenty (:20) second promotional spot which will be broadcast during weekend programming on MTV and re-airing through the premiere airing of the 2022 MTV Movie & TV Awards (which is currently scheduled to air between 12:00 PM (EDT) on Saturday, June 4, 2022 through 12:01 AM (EDT) on Monday June 6, 2022) (the “**Promotional Spot**”) to count as one “**Entry**”.

You must have a Twitter account to submit and Entry to this Sweepstakes. If you do not have a Twitter account, visit <http://www.twitter.com> and follow the on-screen instructions to register for free. By submitting an Entry, YOU AGREE TO THESE OFFICIAL RULES. You are required to follow the Sponsor’s @MTVAwards Twitter account so you can see the Winners’ announcements to see if you’ve won (pending verification) in addition to the winner notifications described in Section 5 below.

Entrants must complete their Entries as directed and within the timeframe specified by Sponsor. The failure of an entrant to comply with the foregoing may result in an incomplete or disqualified Entry. Sponsor has the sole discretion to determine whether a post qualifies as an Entry.

Your privacy settings must be set to “public” in order to submit an Entry. If your Twitter is set to “private” or protected mode,” your Entry may not be visible to Sponsor and may not thus be received by Sponsor.

Entrant agrees, by entering this Sweepstakes that he/she is solely responsible for all data charges that may be incurred. All such charges are billed by and payable to your mobile service provider. Please contact your participating mobile service provider for pricing plans, participation status and details. Limit five (5) Entries per person.

All Entries submitted in accordance with these Official Rules shall be hereinafter referred to as (“**Eligible Entries**”). Please note that if you do not respond to the winner notification described in Section 5, you will be disqualified and another winner may be selected. Potential Winners may be required to show proof of being the authorized account holders of the accounts associated with the Entries. The authorized account subscriber is defined as the natural person who is assigned an account by the applicable service provider.

- Any other content, display, materials and/or images that is or could be considered inappropriate, unsuitable or offensive, as determined by Sponsor in its sole discretion
- Any minors

Language and themes contained in Entries will be evaluated by Sponsor based on content and societal acceptability.

Sponsor is not obligated to, use, publish, display or broadcast any submitted Entries (in whole or in part). Each entrant acknowledges that Sponsor will rely on such entrant's agreement and compliance with these Official Rules when entrant submits or attempts to submit the entry. Sponsor reserves the right to reject any Entries that it deems, in its sole discretion, to violate any of its standards and practices policies or the terms and conditions set forth in these Official Rules. Sponsor may modify or edit any materials related to an Entry or request entrants to do so, so that such materials meet such guidelines.

This process will be repeated until a potential Winner responds, as time permits, in Sponsor’s sole discretion. In the event of non-compliance by the potential Winner such potential Winner shall be disqualified and all privileges otherwise due as a Winner shall be terminated and an alternate potential Winner may be chosen from among all of the remaining Eligible Entries received, if time permits, in Sponsor’s sole discretion. The approximate retail value (the "**ARV**") of each Prize is \$550.00 (USD) and the total ARV of all prizes to be awarded in this Sweepstakes is up to \$4400.00 however, the actual final retail value of the Prize may be higher or lower based on current market conditions at the time of award. Any difference between the final value and the approximate retail value will not be awarded.

Winner will be solely responsible for paying all applicable federal, state or local taxes on prize based upon the value of the prizes as set forth in these Official Rules and will be issued an IRS form 1099 for the value as published in these Official Rules.
